INTRODUCTION

The Murray Darling Association (MDA) is a membership based body representing local government and communities across the Murray Darling Basin.

The Basin covers 14 percent of the land mass of Australia, and there are 167 local government organisations across the Basin whose communities derive their wellbeing from the resources of the Basin.

Around 100 of these organisations are now members of the MDA.

OUR HISTORY

The Murray Darling Association initially formed in 1944 with the objective of providing sufficient water supplies and hydro-electricity to support sustainable production in agriculture, business and industry across the basin.

This organisation was instrumental in securing support for the Snowy River Diversion and its associated hydro electricity scheme.

Today, with the implementation of the Basin Plan impacting every community across the basin, the purpose of the MDA has never had greater relevance.




CALL TO ACTION
